Your Responsibility Tampering with the backflow assembly device is prohibited aside from turning water on and/or off from the valve handle or hydrant valve. All costs for damages and repairs to equipment will be included in your billing. When your project is completed and we have picked up the equipment, your account will be closed and all charges will be paid from the deposit. In the case of a lost or stolen backflow assembly, the deposit will be forfeited.

Proper Use of Backflow Assembly Device and Fire Hydrants It's is important that you open the fire hydrant completely – without using force. All hydrants are equipped with a drain valve that will not close until the hydrant is completely opened. If this is not done properly, water will come up and around the sides of the hydrant. Fire hydrants should be closed at the end of the work day so it can be used for fire protection. We recommend using a gate valve if the hydrant is going to be opened several times in the same day. Always turn the fire hydrant and its meter on and off slowly to prevent damage to the backflow assembly and avoid creating water quality issues.

Risk of Loss or Damage The Customer assumes all risks of loss or damage to the equipment from any cause, and agrees to return it to the Company in the condition received from the Company.

Rental Term This Rental shall begin on the above effective date and shall terminate upon the time of removal from the job site.

Maintenance and Repair Western will maintain the leased equipment in working order as part of this contract. Response time can take up to 48 hours to fulfill this maintenance at no cost to the customer. Western is not responsible for damage to device other than wear and tear and no consequential damage under any circumstances. Western Backflow Testing shall have the right to inspect the equipment during Customer's normal business hours. Damage to the assembly caused by others will be billed accordingly for repairs and/or parts.

Warranty Western Backflow Testing LLC makes no warranties; expressed or implied, as to the equipment rented. The Customer assumes the responsibility for the condition of the equipment.

Freeze Protection The Customer assumes all risks of damage to the rented hydrant meter backflow assembly associated with freezing conditions. The Customer shall be solely and financially responsible for the damaged rental equipment until the date Western Backflow Testing LLC has removed the rental equipment.

Entire Agreement and Modification The failure to make a required payment under this Rental Agreement when due shall constitute as default. Western Backflow Testing LLC has the option of immediately removing the equipment for the purpose of payment defaults. This contract constitutes the entire agreement between the parties. No modification or amendment of this contract shall be effective unless in writing and signed by both parties. This Contract shall be construed in accordance with the laws of the State of Arizona.
